ROYALTY TERMINATION AGREEMENT – MACQUARIE BANK LIMITED APPENDIX 3B AND SECTION 708A NOTICE

Please find attached an Appendix 3B and Section 708A Notice which includes the issue of 1,780,416 ordinary fully paid shares to Macquarie Bank Limited ('MBL') being settlement in respect of the termination of the MBL Royalty Deed held over certain tenements held by the Company at its Mount Morgans Gold Project.
