

## COMPLETION OF SHARE PURCHASE PLAN

Dacian Gold Limited (ASX: DCN) (“**Dacian**” or the “**Company**”) advises of the issue of 13,209,010 ordinary fully paid shares at \$0.28 per share, raising approximately \$3.7 Million before costs pursuant to the share purchase plan (“**SPP**”) announced to ASX on 26 May 2021.

The SPP was undertaken in conjunction with the fully underwritten A\$40 million institutional placement (“**Institutional Placement**”) announced on 26 May 2021.

An Appendix 2A is attached to this announcement in respect of the issue of the abovementioned SPP securities.
