# SIGNIFICANT RESULTS RETURNED FROM NEWLY IDENTIFIED MINERALISED FOOTWALL BIF UNIT AT WESTRALIA

- The first hole of a 6,600m 14 hole resource-extension, high impact diamond drilling program at Westralia returned the following excellent results:
  - o 5.3m @ 12.2 g/t Au from 265.15m in 13MMRD016 (ext), and
  - o **4.1m @ 9.9 g/t Au** from 281.9m, also in 13MMRD016 (ext)
- The new intersections are located 1,100m north of, and within the same mineralised BIF complex, that hosts the 850,000 ounce, 5.8 g/t Au Westralia underground Mineral Resource.
- The intersections lie within a newly identified, potentially continuous footwall BIF unit that has not previously been the subject of exploration drill testing at Westralia. This footwall BIF unit has only been intersected in two previous drill holes (each drilled by Dacian in 2014) over a strike distance of 600m, and returned:
  - o 2m @ 18.0 g/t in 14MMRD024 (see ASX announcement 15/10/2014)
  - o 4.2m @ 6.8 g/t in 14MMRD026W1 (see ASX announcement 15/10/2014)
- The remaining thirteen holes to be drilled as part of the Westralia resourceextension drilling program will:
  - infill this new and highly prospective mineralised footwall BIF unit north of Westralia, and
  - test the mineralised BIF complex beyond the existing Mineral Resource over a total strike length of 1,700m



Dacian Gold Ltd ("Dacian" or "the Company") (ASX:DCN) is pleased to announce positive drilling results from 13MMRD016 (ext), the first hole of its 14-hole, high impact resource-extension drill program at Westralia, as announced to the market on 4 June 2015.

#### Resource-Extension Diamond Drilling Program

Dacian announced on 15 October 2014, five high grade drill results from six widely-spaced diamond drill holes testing for potential mineralisation in a previously undrilled area north, and along strike of, the 850,000 ounce, 5.8 g/t Westralia Mineral Resource. The five intersections confirmed high grade gold mineralisation existed for up to 1,200m north of, and within the same BIF package that hosts, the Westralia Mineral Resource. The five intersections reported were:

As announced to the ASX on 4 June 2015, Dacian embarked on an 8 hole 4,000m diamond drill program to infill the 2014 Dacian intersections, listed above. Subsequent to the 4 June 2015 ASX announcement, Dacian increased the drill program from 8 holes for 4,000m to 14 holes for 6,600m. An additional six holes testing below and to the south of the Morgans North open pit (see Figure 1), increases the strike extent resource-extension program from 1,200m (8 holes) to 1,700m (14 holes). The broad drill hole spacing over the 1,700m strike of the Westralia BIF unit being drill tested is approximately 150m.

#### Intersections Returned from the First Hole, 13MMRD016 (ext)

The 2m @ 18.0 g/t Au and 4.2m @ 6.8 g/t Au intersections listed above are situated within a poorly tested footwall BIF unit that is part of the 30–100m thick BIF complex that hosts the 850,000 ounce Westralia Mineral Resource, located up to 900m to the south of these intersections.

Given the thickness of the BIF complex, exploration drilling conducted at Westralia over the last 35 years, has not routinely tested through the entire BIF package. This is certainly the case for much of the historic shallow drilling testing the BIF complex north of Westralia toward Morgan North (see Figure 1). The deeper drilling conducted by Dacian in 2014 that was testing the BIF complex north of Westralia (see ASX announcement 15 October 2014) tested through the entire BIF complex. As noted above the drilling was successful in defining high grade mineralisation in two wide spaced holes in a hitherto poorly tested footwall BIF within the BIF complex.


On the basis that it seemed likely there existed a highly prospective, and poorly tested footwall BIF unit, the first hole of Dacian's current resource-extension diamond drilling program was to extend a 2013 Dacian drill hole, 13MMRD016, which had drilled the hangingwall BIF, but had not tested for any footwall BIF unit. The hole had previously been drilled to a depth of 212m.

Dacian's extension of 13MMRD016 (ext) at 212m intersected a further two highly mineralised BIF units:

- o 5.3m @ 12.2 g/t Au from 265.15m, and
- **4.1m @ 9.9 g/t Au** from 281.9m.

The hole was completed at 327.4m having passed into the extensive footwall basalt sequence that is defined at Westralia as footwall to the BIF complex. See Table 1 and Appendix I for all drill hole details and requisite disclosures.

Figure 1 shows the location of the 13MMRD016 (ext) footwall BIF intersections along with those holes of the current 14 hole resource-extension program that (i) have been drilled and are awaiting assay, and (ii) remain to be drilled. It is expected all infill resource-extension drilling will be completed at the end of June, with final results returned in July.

The remaining 13 holes of the current drill program will test the entire thickness of the BIF complex, with a clear focus on infill testing the mineralised footwall BIF unit. Dacian is highly encouraged that it has identified a new, well mineralised BIF unit for up to one kilometre north of the existing 850,000 ounce Westralia Mineral Resource. If the infill drilling returns mineralised BIF intersections, the Company will release an updated Mineral Resource for Westralia after the return of all assays, most likely late July, early August.

## About Dacian Gold Limited

The Mt Morgans Project hosts high grade Mineral Resources of 2.1 million ounces at an average grade of 2.6 g/t gold, including Ore Reserves of 136,000 ounces at an average grade of 6.2 g/t gold. In addition, the Company has identified multiple exploration targets and resource extension opportunities. If proven, they will enable growth of the Mt Morgans' existing Mineral Resource and Ore Reserve base.

Dacian Gold has a strong Board and Management team which includes Rohan Williams as Executive Chairman; Robert Reynolds (formerly non-executive Chairman of Avoca Resources Ltd) and Barry Patterson (co-founder and non-executive Director of GR Engineering Ltd) as non-executive directors.

Dacian's strategy at Mt Morgans is evolving toward mine feasibility and potential mine development. It has identified two large mineralised systems at Westralia and Jupiter where it believes mine development at each site is a possibility, and will be the subject of ongoing drilling and feasibility studies. Dacian considers a high grade Ore Reserve of at least 600,000 ounces of gold is reasonably likely to provide sufficient returns to justify the investment capital required to construct an ore processing facility at the project.
